# **8 Department Head Reports:**

**Keehne-** Report is in the packet.

Keehne shared updates that need to be implemented to City Code 13.04.160 Outdoor use of water for users of water supplied by the city during summer months. The updates are to 1. restricted period- April 1st through September 30th during the hours of 12am until 11:59pm, commencing June 11, 2019. Water may be used for outdoor purposes by all users of water supplied by the City of Burlington on May 31st, July 31st and August 31st. 4. large irrigations may only use water supplied by the City of Burlington between the hours of 12am and 6am during the restricted period. Keehne is not requesting a motion at this time. He is asking for Councils direction and would like to have the updates in Ordinance at the next meeting for approval. Keehne explained to Council that the reason for the change is the City is experiencing a drop in the water levels which causes our high service pumps to pump more water out than we can bring in. We have not gotten into highest usage month for the summer and Keehne feels this change will help off-set the usage between the hours of 9pm and 6am.

Shared bids on the Community Center Maintenance and Repair: Keehne recommended Skarco's bid of \$14,940.00.

Keehne discussed with Council the process that he is working on for annexation into the City. On June 4<sup>th</sup> Keehne will share this information with the Planning and Zoning Commission.

Updated Council on the meeting that he attended with HUD about the Housing Authority.
