

**CITY OF BURLINGTON
ORDINANCE NO. 996**

AN ORDINANCE ADOPTING A BUDGET FOR THE CITY OF BURLINGTON FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2025 AND ENDING ON THE LAST DAY OF DECEMBER 2025.

WHEREAS, on October 28, 2024, the City Administrative submitted a proposed budget to this governing body for its consideration; and,

WHEREAS, upon due and proper notice, published or posted in accordance with applicable law, said proposed budget was open for inspection by the public at a public hearing held on November 12, 2024 and interested taxpayers were given the opportunity to file or register any objections to said budget; and,

WHEREAS, on December 09, 2024, the City Administrator submitted a final budget to the governing body for its consideration; and,

WHEREAS, whatever increases may have been made in expenditures, like increases were added to the revenues or planned to be expended from reserve/fund balances so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURLINGTON, COLORADO:

SECTION 1. The 2025 Budget of the City of Burlington, Colorado, as presented by the City Administrator and amended up to the date of this ordinance and as summarized as attached, shall be and is hereby adopted as the official budget for the fiscal year of 2025;

SECTION 2. The adoption of the 2025 Budget, by this ordinance, shall and does hereby constitute the basis for appropriation, by ordinance, of the several sums specified therein as expenditures from the various funds and of the total such expenditure;

SECTION 3. That the budget hereby approved and adopted shall be signed by the Mayor and made a part of the public records of the City of Burlington, Colorado.






